- A deposit of \$250 dollars will hold the puppy of your choice (if that puppy has not already been reserved), until eight weeks of age. This is a non-refundable deposit.

Health Guarantee

- At the time of sale, breeder believes the puppy is a healthy, sound, quality puppy that is current on all of its vaccinations. The puppy's health is guaranteed for 4 days after pick-up or shipment. We do not guarantee against Parvo, Corona, or Giardia after 4 days from the date of purchase. Buyer agrees to have puppy examined by a licensed veterinarian of their choice within 4 days. If the veterinarian detects a problem within that period, a full refund of purchase price or a replacement puppy of equal value, if one is available, will be granted upon the return of the puppy and registration papers. Buyer must also provide a written statement from the examining veterinarian detailing the health problem. If the buyer fails to take the puppy to be examined by a licensed veterinarian or if the buyer decides to keep the puppy after discovering a problem, the breeder will not be responsible for any veterinary costs incurred. The Breeder has the right to have the puppy examined by a veterinarian of the breeders choice, at the breeders expense, for a second opinion.
- Puppies hips and elbows are guaranteed for the first year from any dysplasia caused by a genetic defect as deemed by two licensed veterinarians of breeders choice. Guarantee does not include dysplasia from any of the following; poor nutrition, or trauma injury from jumping or falling. If the puppy does develop dysplasia due to genetic faults, the breeder will hold the right of choosing one of these options.
 - Buyer may return the puppy and it will be replaced with one of equal value, when one becomes available.
 - The Breeder has the right to seek a second opinion by a veterinarian of breeder's choice. If any disputes arise to the cause, both parties agree to select a third party to resolve the dispute. Expenses will be split evenly.
- New owners must take their puppy to their veterinarian within 4 days of receiving puppy for examination, testing for worms if necessary, and to schedule further immunizations. Failure to have the puppy examined by a vet within 4 days of date puppy was received, or if purchaser fails to provide required immunizations or dewormings, this health guarantee will be void.
- The buyer shall assume full responsibility of general health, appearance, and temperament of the said animal and will maintain the animal in good health at all times. Buyer has been informed that this animal will require certain vaccinations (Rabies, DHLPPC, Bordetella) and should be examined by a veterinarian and be checked annually for heartworms. Heartworm preventative should be given daily/monthly as advised by your veterinarian.
- The buyer agrees that if for any reason, he/she is unable to keep this animal, the seller will be contacted. With this something will be worked out to find a new home for the pet.
- New owner agrees to keep the puppy at home and away from other dogs, public places, parks and will use care in allowing others form outside their home to pet or touch the puppy. This is to protect the puppy from exposure to parvovirus and other infectious illness. New owners will not enroll the puppy in obedience

training classes until immunizations are completed, this is usually in the range of 16 to 20 weeks of age, according to your veterinarians schedule.

- Further more the seller holds the right to investigate into information given to us about neglect or abuse of purchased animal. If abuse or apparent neglect is proven the animal can be reclaimed by the breeder with no refund given.
